FY19 1st Cycle Rural Markketing Grants Recommended Allocation

HUTCHISON: FY19 1st Cycle Rural Markketing Grants Recommended Allocation, for possible

action by the Commission. Mr. Peterson, please kick this off.

PETERSON: Thank you. For the record, David Peterson. In your packets you all have a copy

of the 1st Cycle fiscal 19 grant recommendations. At this time, I'm going to let Teri Laursen, Director of Sales and Industry Partners team walk you through the grant recommendations that were reviewed and approved by the Territory

Advisory Committee a week ago today.

LAURSEN: For the record, Teri Laursen, Director of Sales and Industry Partners. I come

before you today to request approval of the FY19 First Cycle Rural Marketing

Grants.

Rural Marketing Grants help the communities of Nevada market their destination to potential visitors around the world in an effort to generate overnight stays. The funds are intended to develop, promote and improve tourism to and within the state. TravelNevada awards \$1.65 million per year to rural partners for a variety of marketing projects which include video production; online marketing, radio, television and print advertising; brochures; tourism community assessments; attending travel/trade shows and more. Non-profits and local tourism entities are eligible to apply for fuding in this program.

Christian Passink and I reviewed and discussed the grants with Territory Advisory Committee at a meeting on June 18, 2018 and came to a consensus on the recommendations that are before you today.

This year we received 216 grant applications requesting \$1,994, 081. We are recommending funding for 178 projects totaling \$1,006,203. This would leave a balance of \$643,797 for the second cycle. There was one first-time applicant.

We are happy to entertain questions or comments you may have about the recommendations before you.

HUTCHISON: Ms. Laursen, thank you very much for your report and introduction. Members

of the Commission, after review of the materials, do you have any questions
